Please read carefully

I hereby apply for a water connection from Council's reticulation main to my property and agree that a registered licensed plumber will be responsible for all plumbing and drainage installations.

I understand that Council shall provide and install metered water service from a Council water main for a distance up to 30 metres, if my application is approved by Water & Sewerage Services. If the metered water service is beyond 30 metres, Council shall carry out the appropriate work and the property owner shall bear the cost of the water service extension (in accordance with Council's procedure 2.4.1(a)). If I require the connection to an alternative point, I agree to pay any additional costs involved.

I hereby authorise Council staff to enter onto the property for the purpose of providing the water connection, installation of a meter, meter reading, inspections, repairs and any associated works.

I also understand that for **properties outside gazetted village or town areas**, where the supply will be from a Council Trunk Main and where permitted, the connection is limited to 20mm diameter and will generally have the water meter assembly immediately adjacent to the water main. Water service from this water meter is the responsibility of the owner and the service must be made direct to an on-site storage tank. I

acknowledge that continuous water supply from Council's trunk water main cannot be guaranteed. Council suggests that the on-site storage tank (approximately 5,000 litres) ensures a minimum of 24 hours (1 day) supply for household purposes.

I understand that under the *Government Information (Public Access) Act 2009* details contained on this application, including my name and address, will become publicly available.
