PRICING POLICY

Term

Definition

1. Full Cost Recovery
Recovery of all direct and indirect costs associated with providing a service including, in some cases, making provision for future expenditure.
2. Partial Cost Recovery
Subsidised operations which are of benefit to the community as a whole, particularly keeping low-income users in mind.
3. Market Pricing
Council will not use subsidies to compete unfairly or price others out of the market.
4. Statutory fees
Statutory fees are charged at rates defined by the state government in relevant legislation and regulations or certificates. These fees will only be varied by changes to the legislation concerned. The schedule of Fees and Charges reflects the current Statutory Fees. All Fees gazetted by government may not appear in the published Council Fees & Charges document.
5. GST
Goods and Services Tax (GST) will be included on those fees and charges that are considered to be for a taxable supply. Those fees and charges that are of a regulatory nature are GST exempt.
GST has been included on or excluded from fees and charges in a manner consistent with the Commonwealth Government's A new Tax System (Goods and Services Tax) Act 1999 and Division 81 Determination. Should this legislation be amended, the current treatment of GST and the impact on the relevant fees and charges will be reviewed.

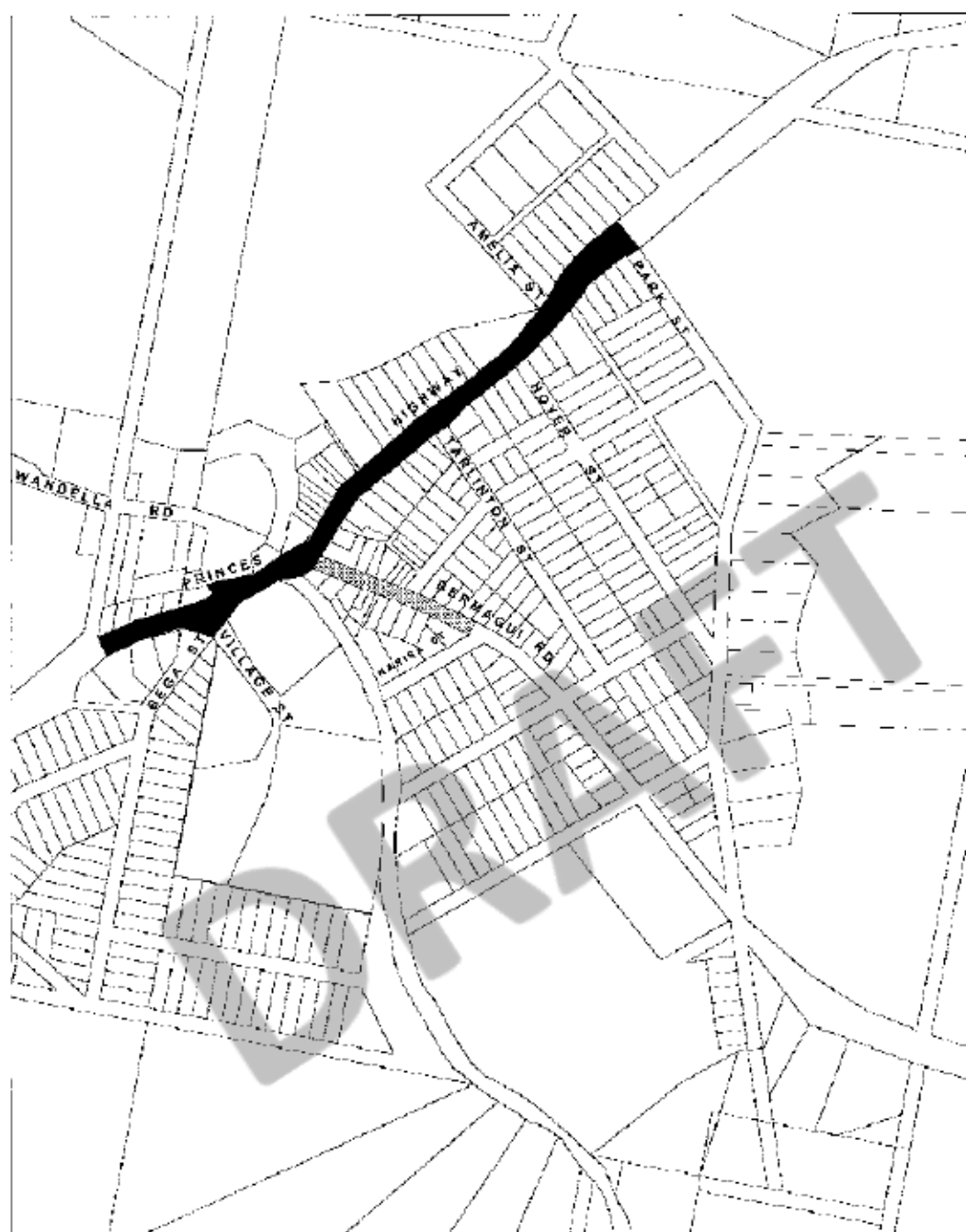




LOCAL APPROVALS POLICY No. 1

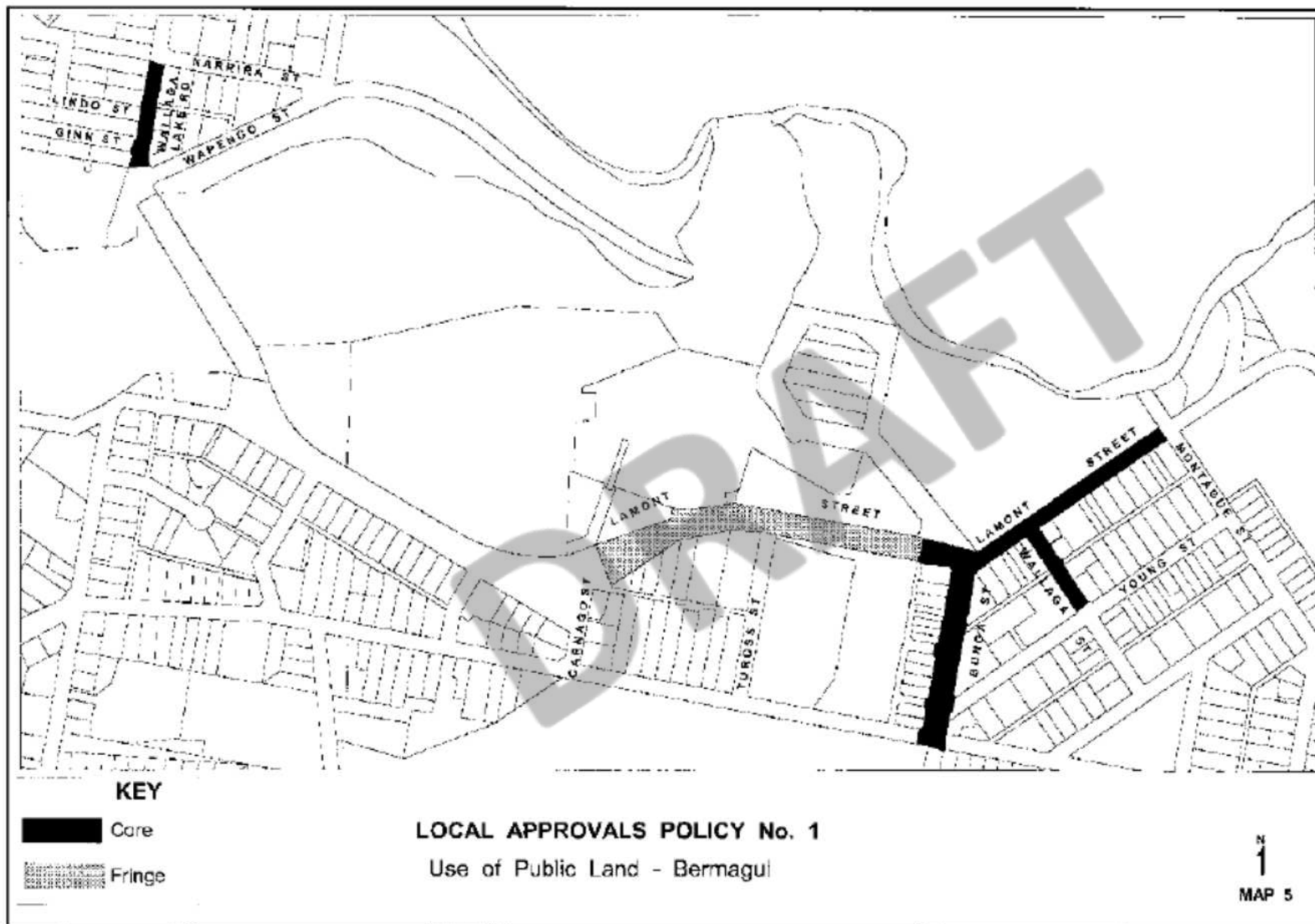

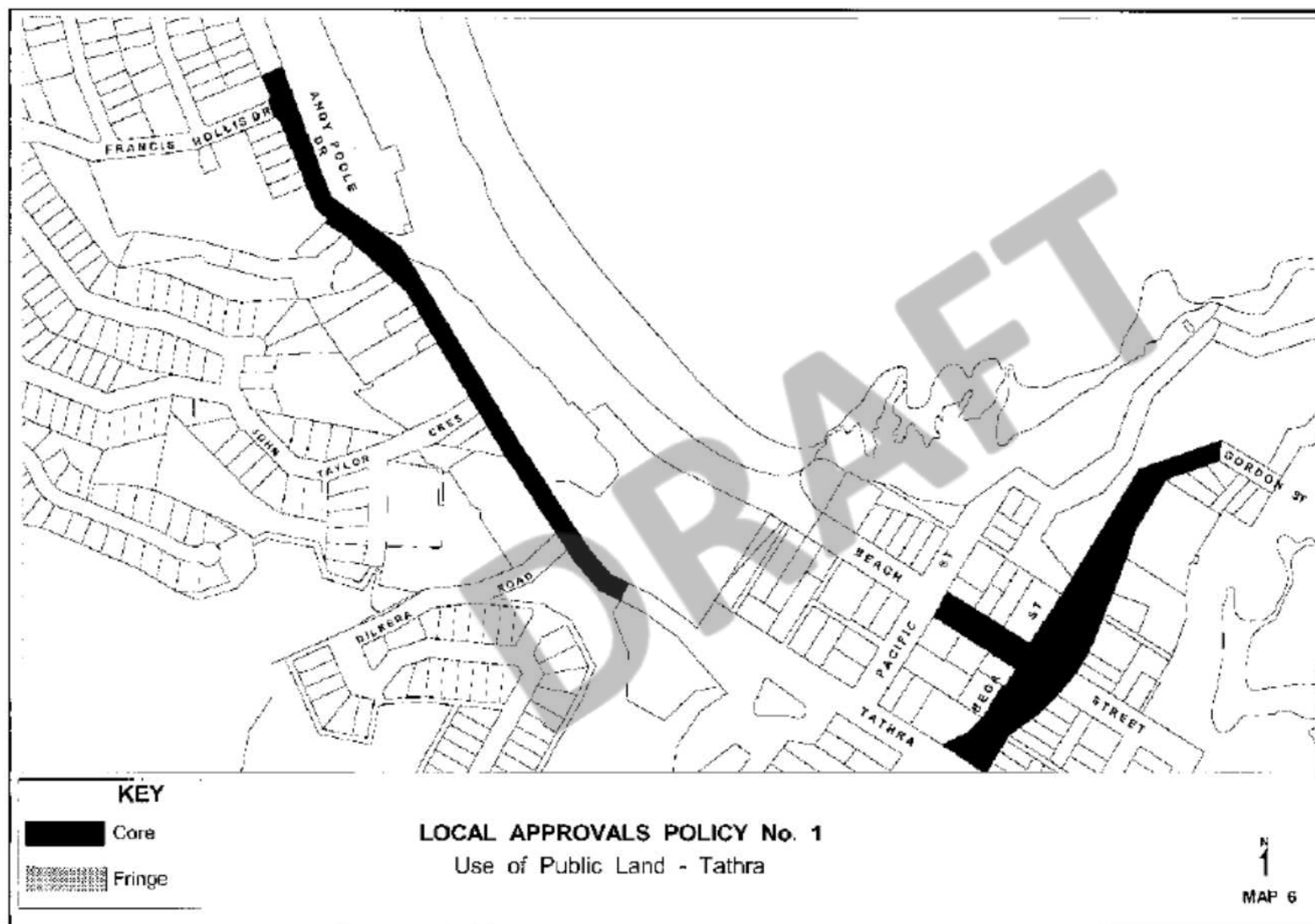

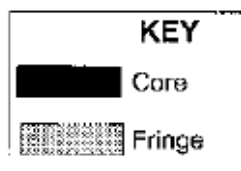
