Employment in the Visitor Economy

The estimates of the 2018-19 visitor economy employment by the National Economics Institute of Economic Industry Research (NIEIR) as presented on the Bega Valley Shire economic profiling tool are summarised as follows:

- Total of visitor and hospitality sales in the Bega Valley Shire in 2018-19 = \$274.7M
- There was a small increase on the 2017-18 sales levels of around 1.7%
- Direct full time equivalent jobs in the tourism sector were estimated at 777 jobs
- Indirect full time equivalent jobs were estimated at 528 jobs

Visitation increases from Eden cruise ships

Visitation from cruise ship passengers to Eden is expected to increase in future years. The table below details current projections from financial year 2017-18 to 2021-22.

Using the 2017-18 financial year as the base year, a compound annual growth rate of 18.4% was calculated and applied up to financial year 2025/26 after which a 10% growth rate was applied based on cruise ship passenger projections and advice supplied by the Port Authority. To model the increase visitation from cruise ships over 10 years, these rates have been applied from 2020-21 to 2029-30.

Assuming the number of passengers in financial year 2017-18 of 25,796 is included in the Tourism Research Australia statistics, passenger numbers over and above this rate have been calculated to understand the total increase in visitation to the Bega Valley Shire over a 10 year period from financial year 2020-21 to 2029- 30.

Based on this analysis, and an expenditure of \$143 per trip for domestic day trip visitors (on the assumption cruise liners will spend in accordance with domestic day trippers), this increased visitation translates to **\$93,069,658** additional expenditure in the tourism sector in the Bega Valley Shire over 10 years.
