#### 1 Welcome and apologies

That the apologies submitted by Wendy MacDonald and Graham Carmody for their inability to attend the meeting be accepted.

#### 2 Confirmation of minutes

That the minutes of the previous AIAC meeting held on 10 August 2020 be taken as read. Motion moved by Jenny Robb and seconded by Colin Dunn. Unanimously adopted.

#### 3 Presentations to the Committee

# 3.1 BVSC Water and Sewer Administration Building Design - Nathanael Wearne and Chris Best

Nathanael Wearne and Chris Best presented the concept design plans for the BVSC Water and Sewer Administration Building Design. Mr Wearne requested the Committee to look at the facility and provide any feedback. This building will harness the opportunity to bring the whole Water and Sewer Team together.

The question was asked whether there are many staff with accessibility issues and why there are differing levels that prevent access for all. Despite the fact that there are no staff with disability access issues currently, the building is being built to suit future access.

Dr Howe asked whether the Committee would like to have further consultation on the design phase of this project.

Questions were asked about bathroom and hallway facilities as well as mobility parking space. Mr Wearne reiterated that the facilities would be suitable for disabled access.

Ms Gates asked whether the plans were accommodating for people with vision loss. Mr Best said he would consider all aspects that Ms Gates had to offer in this space.

**New Action:** Secretariat to circulate the plans.

**New Action:** Mr Best and Ms Gates to discuss potential vision impairment design solutions.

#### 3.3 Disability Inclusion Action Plan (DIAP) - Carol Bunt

Ms Bunt presented the principles of the DIAP.

- The Disability Inclusion Action Plan (DIAP) provides an opportunity for Council to think about how it can help people with disability live more fully in our region.
- The DIAP will include specific actions that can be measured and that Council will deliver, lead, influence or advocate for. It will be linked to Council's planning documents, be integrated into its work and reported on annually.

#### Consultation to date:

- Workshop with the Access and Inclusion Advisory Committee for special insights into inclusion and into the operations of Council.
- Discussion with the Bega Eden Merrimans Committee.
- Interview with Uniting, Local Area Coordinator for the National Disability Insurance Scheme.
- Extensive consultation across Council through nominated officers, Community Connections, People and Culture, Media and Communications and Senior Leadership Group.
- A range of actions for the DIAP were identified then prioritised based on what is achievable within operational plans and to deliver outcomes.
- Councillor workshop on 21 October 2020.
- The proposed actions, once endorsed by Council, will be reported on annually.

#### Themes of the DIAP:

#### 1. Developing positive community attitudes and behaviours

- Key question: How can we learn about and explain the benefits of diversity and inclusion for our community?
- o Annual inclusion awareness training for staff
- o Development Hub providing advice about Liveable Housing design
- o Including disability inclusion in event planning guides
- o Review Council's style guide to check inclusive language
- Hold a Big Day Out focused on inclusion and diversity
- A communication strategy focused on what inclusion means and what council is doing in the DIAP

#### 2. Creating liveable communities

- Key question: What are some everyday changes that could help people with disability live full lives and benefit everybody?
- Continue advocacy for accessible public housing
- Review and update land use plans to allow for accessibility where possible including shared pathways
- Develop and implement a comprehensive Bega Valley Transport Strategy in collaboration with Transport NSW
- o Review the issues for people with disability during disaster events
- A Council action plan to increase accessible parking and town centres

- Look to fund a specialised change facility
- Look to resource a Tourism Access Sapphire Coast Strategy

#### 3. Supporting access to meaningful employment

- Key question: How might Council show leadership in the employment of people with disability?

- A progressive review of physical layouts in Council
- Consider partnership with disability recruitment specialists
- Working with local schools to model inclusive work practices

- Customer service to offer specific times for PWD
- Events guide to include a standard pre-attendance document
- o Key Council documents available in accessible formats
- Library and Gallery to offer more events for people with sensory impairments
- Inclusion integrated into project planning
- Council to explore accessible toilets for events

- 25 November 2020 Council considers draft for public exhibition
- Public exhibition from 26 November to 22 January 2021
- 23 February 2021 Council considers updated DIAP for proposed launch in 2021

#### **AIAC Discussed:**

Mr Johnston mentioned that there is no change table at Pambula Pool which inhibits him from using the facility. Mr Finneran said that the change table is not appropriate. Mr Grady commented that the footprint of an accessible/high needs facility wasn't considered when the Pambula Pool was constructed and it is difficult to adjust.

Ms Dunn commented that someone from the Committee should be involved in the Councillor workshop. Dr Howe agreed with this.

**New Action:** Mr Johnston and Mr Grady to discuss the facilities at the pool to see what can be done about the change table situation.

**New Action:** Ms Gates to pass on information for contacts for accessible toilets to Ms Bunt for the events planning part of the DIAP.

**New Action:** Secretariat to circulate the Disability Inclusion Action Plan for feedback when on public exhibition.

**New Action:** Ms Robb, Mr Finneran and Mr Grady to review the layout of the Barclay Street Pavilion layout to ensure suitability for multi-purpose use.

#### 5.4 Other Business

#### 5.4.1 Tura Access

Mr Finneran spoke to this item explaining that a community member who is totally incapacitated due to medical illness is currently unable to use the recently upgraded granite pathway to the North Tura Beach lookout. Due to this affecting the community members wellbeing, the family have offered to pay for the upgrades to pathway to make it suitable for this person to use their wheelchair to access the lookout.

Mr Finneran requested that work commences immediately to complete the upgrade to enable the community member to visit the beach. Mr Dunn added that the pathway has been impacted by recent rain and has deteriorated.

Dr Howe mentioned that this project is being considered through the community project proposal process. This community proposal will be going to the 25/11/20 Council meeting for consideration.

Dr Howe updated the Committee regarding the progress of the 2020 round of Access Improvement Grants.

#### **Excerpt from Council minutes:**

82/2020 Council RESOLVED on the motion of Crs Bain and Dodds

- 1. That Council adopt the Access and Inclusion Advisory Committee's recommendations (Attachment 1) to award the following Grant allocations, for a total value of \$15,600:
  - a) Panboola Pambula Wetlands and Heritage Project Inc for the 'Improving disability parking at Panboola' project (\$600);
  - b) Bermagui Surf Life Saving Club for the 'Same Wave An All Abilities Aquatic Program' (\$5,000);
  - c) Wolumla Football Club for the 'Wheelchair friendly picnic tables' project (\$5,000); and
  - d) The Trustee for the Australasia Property Unit Trust for the 'Accessing the Australasia' project (\$5,000).
- 2. That unspent funds of \$4,920 from the 2020 Access Improvement grant round be allocated towards a grant application to support accessible tourism.
- 3. That Council thank the Access and Inclusion Committee, and its Grants Sub-committee, for coordinating the 2020 Access Improvement Grant Program.
- 4. That Council officers write to all applicants advising them of the outcome of their applications.
