3. Update of Actions - April Meeting

Overview of works undertaken in response to actions identified in the April 4 meeting notes:

Action Council's Leisure and Recreation Coordinator to prepare a report to Council for the adoption of the Facility Management Plans for Dickinson Oval, Wolumla Recreation Ground, Berrambool Sports Complex, Pambula Sporting Complex, Barclay Street Sports Complex and George Brown Oval.

Outcome

The Facility Management Plans went before the 20 July 2016 Council meeting and unanimously adopted. The adopted plans have been posted to Council's website and distributed to the respective committees.

Action Following extensive discussion around the direction forward surrounding user fees the committee resolved that user fees would be 25% of the cost to Council (as outlined the Facility Management Plan at any particular site. Leisure and Recreation Coordinator Justin Welsford and Leisure and Recreation Manager John Grady to include this updated method in the draft fees and charges.

Outcome

The 25% method (as per the direction of the S355 committee) was included in the draft fees and charges and eventually adopted as part of the 2016/17 fees and charges and budget.

4. Master Planning Projects – Bega & Pambula (update)

Council's Manager of Leisure and Recreation John Grady presented the adopted master plans to the meeting, explaining that they were adopted by Council (Bega on April 6 and Pambula on June 8). John outlined that there is money in the 2016/17 capital works budget for the survey and design phase at each site.

Action Council staff to ensure the survey and design phases of both projects are completed in 2016/17.

5. Sportsgrounds Booking Forms and Procedures (website)

Leisure and Recreation Coordinator Justin Welsford informed the meeting that the adopted sportsground booking forms were now available on Council's website for use. Some clubs and groups had completed their forms however it was still an issue that many others still weren't using these.

Action Justin to contact the schools and clubs, with the assistance of the sportsground committees, to encourage the use of the forms.

Leisure and Recreation Coordinator Justin Welsford informed the meeting that the Facility Management Plans were now being put into action. There will be consistent contact with the various site committees surrounding these throughout the financial year.
